The Company respects and supports the dignity, wellbeing and human rights of all stakeholders and is committed to developing a culture which inculcates respect and support for Human Rights and seeks to avoid connivance in Human Rights abuses.

SCOPE

The Human Rights Policy (“the Policy”) is applicable to our Company’s Board of Directors, management, employees, trainees and persons who are not employees but authorized to act on behalf of or represent the Company.

The Company also encourages its key stakeholders throughout the value chain to adopt strong human rights standards in-line with the Universal Declaration of Human Rights as a part of their conduct.

HUMAN RIGHTS ASPECTS

The Company is committed in respecting human rights and avoiding involvement in human rights abuses; and identifying, assessing and minimizing potential adverse impacts and resolving grievances.

The Company endeavours to achieve its commitment by:

- Maintaining positive legal compliance to applicable regulatory human rights requirements;
- Respecting human rights across all jurisdictions where it operates, identifying and preventing human rights violations in any form, and mitigating related impacts;
